I PRESIDENT THALEN ASKED IF THERE WERE ANY QUESTIONS FROM THE AUDIENCE

- Karen Audette expressed satisfaction with the new 9 period day, which was negotiated by the Teacher's Union. Each period was shortened in the High School by two minutes and a 9th period added. She congratulated the High School for a great plan.
- Bill Whaley brought up his concern about the dress code being enforced among some students and not all. He felt that some students were being singled out and that others were getting away with ignoring the dress code rules and that he didn't think that was fair. If you have a dress code then everyone should follow it. Mrs. Thalen advised him to contact the building Principal and make an appointment to discuss the problem as soon as possible.
- Pat Noto inquired about the Nursing staff at the elementary schools. She was not clear on whether there would be adequate nursing staff and asked if the Nurse's Aide that was hired had a nursing license and was a trained EMT. Dr. D'Ambrosio responded that yes the new Nurses Aide was EMT trained and would provide suitable coverage during the Nurse's breaks/lunch periods. This aide, however, cannot dispense medication.

- Brian Russell reported an incident that occurred over the Labor Day weekend on the Rocky Point Soccer Field that upset him greatly. He investigated and uncovered that this group called the LA Union, which consisted of 50 – 60 immigrants, were using the Joseph A. Edgar soccer field for a "Practice" and had a permit to use the field. The problem was that he witnessed them drinking, smoking, and urinating on the field. He strongly urged that their permit be revoked as he felt that this was not appropriate behavior and that they left a mess for the school children to be exposed to. He did call the police and filed a report. According to Mr. Russell the police did not follow through with any action. He asked the board if anything was being done about this. Dr. D'Ambrosio stated that the police did not give the school a report at this time however, she was aware of his concerns and replied to Mr. Russell with a letter stating that she had not received any complaints nor was there a report of unusual debris on the field during September 4th or 5th. President Thalen apologized to Mr. Russell that she had not been aware of this and to please send her and the board a letter with all the details. Jane Bonner was aware of the complaint as Mr. Russell had contacted her office to speak to Legislator Losquardo's about this. Ms Bonner was told by Police Officer John Mehan that the LA Union permit was ok and that they would monitor the situation but that they would still be allowed to practice. President. Thalen expressed concern and stated that she was anxious to help with this matter and thanked Mr. Russell for bringing this to her attention. She requested that he send a letter to all the board members. He then passed out copies of the letter that he sent to the school. Mr. Russell asked the board if he could have a meeting with someone about this. Dr. D'Ambrosio recommended that he contact her at her office and they would discuss it further.
- The Rocky Point Middle School Cheerleaders were all present and wanted to petition the board about being allowed to cheer for the Rocky Point Football and Basketball Teams. They felt that this would increase school spirit and that they were dedicated and proud to do it. They asked that they please be allowed to cheer at their games. President Thalen asked them if they had contacted the Athletic Director and they replied that they had not but that they had a petition with 225 signatures. President Thalen directed them to call Mrs. Rose Monz and set up an appointment with Lenny Kies who was in the audience at the time.

- turf field. The present field gets muddy and dangerous to walk on in the rain. President Thalen said Turf would be ideal but knows they have to find the money to pay for it. Mrs. Suhan showed concern about the Junior Varsity team not being proud as their field is embarrassing. President Thalen thanked her for expressing her concern.
- Jane Bonner said the Boys varsity trip to Oneonta was a success. The boys were well behaved, neat and clean and had a great time. The Bus was great and she thanked the staff and the Booster club, Mr. Kies, Mr. Ellis and said this District does nice things for our kids.
