- On March 14th the JAE 5th Grade Student Council and 5th Grade Select Chorus "High Notes" sponsored the annual JAE Senior Citizen St. Patrick's Day Breakfast. The Student Council, under the guidance of Mr. Yashowitz, greeted and served breakfast to the senior citizen guests. The 5th Grade Select Chorus "High Notes" students, under the direction of Mr. Knapp, performed Irish and St. Patrick's Day songs. Students also taught folk dancing to their guests. Ms. Towlen thanked Mr. Yashowitz and Mr. Knapp for this great event.
- The JAE Spring Musical, "Joust," under the direction of Mr. Knapp, will take place on March 19th and March 20th. The musical will be performed by all 5th grade members of the JAE Intermediate Chorus.

Mr. Nofi opened the floor to questions and/or comments from meeting attendees.

- Mrs. Roberta Gerrish expressed her appreciation to the board for conducting a meeting that was both inspiring and uplifting. Reading from a prepared statement, Mrs. Gerrish respectfully submitted to the board a plan for the creation of a Family Recreation Center to be considered on the vacant property that was formerly the home of the golf driving range. Following a five-point financial support plan for this project, Mrs. Gerrish read a poem she wrote in support of the plan.
- Mrs. Burke thanked Mrs. Gerrish for her presentation and recommendations. Mrs. Burke asked if Mrs. Gerrish attends the Rocky Point Civic Association meetings as possible grant proposals for the vacant property are being formulated for consideration by Suffolk County. Mrs. Burke invited Mrs. Gerrish to join the grant committee for further information and to share her ideas and recommendations.
- Ms. Ernestine Franco asked what the district was doing concerning the Gap Eliminating Adjustment issue. Dr. Ring responded that the district addressed this issue during the January Budget Workshop and that information pertaining thereto is included in the January budget presentation which is still available on the district's website. Dr. Ring assured Ms. Franco that this was a number one priority for the district and school superintendents in Suffolk County and throughout the state. Dr. Ring further explained that the district, along with others, lobbied state legislators and Congressman Bishop at a recent forum in an effort to get back aid lost through the Gap Elimination Adjustment (GEA). In addition to securing said GEA aid monies owed to the district, Dr. Ring noted the foundation formula is in need of repair.
- Deacon Gary of St. Louis de Montfort Roman Catholic Church shared his concerns regarding the current endemic heroin use in communities in Suffolk County. Deacon Gary urged the school board and the community in general to be at the forefront of prevention of drug abuse among our youth. Deacon Gary suggested the county consider redirecting available funds from law enforcement to drug prevention. Mr. Nofi thanked Deacon Gary for his remarks and suggestions. Mr. Nofi advised that the school district has worked and will continue to work with local legislators and members of the town board on behalf of our youth.

There were no further questions or comments.
