#### **Executive Session**

Pledge of Allegiance

Mr. Nofi welcomed those in attendance to the meeting. Mr. Nofi announced that in the district's continued efforts to "go green," the Board of Education will utilize school-district laptop computers in place of book binders at monthly meetings thus eliminating the need for large amounts of paper. Mr. Nofi explained that the board members would review materials provided to them via thumb drives and following each board meeting the laptops would be returned for use in the school district.

#### SUPERINTENDENT'S REPORT

Dr. Ring announced during Superintendent's Conference Day, November 2, 2010, instructional staff members participated in workshops focusing upon students with disabilities. Noting the present population of Rocky Point students with disabilities is comprised of approximately one out of six students, Dr. Ring outlined the need for new approaches to differentiated instruction for this student populace. Dr. Ring extended his gratitude to Ms. Anja Groth, Director of Instruction, for her efforts and leadership in

coordinating the conference day program. Dr. Ring also recognized Ms. Groth and her fellow team members for their efforts pertaining to the key elements involved in the Next S.T.E.P. program, the long-range plan for improving academic achievement levels. ## BID #11-15 ON-CALL SERVICES FOR SNOW REMOVAL

Upon a motion made by Kathleen Heggers and seconded by Diane Burke, the following resolution was offered:

**BE IT RESOLVED,** that upon the recommendation of the Superintendent of Schools, the Board of Education awards Bid #11-15 On-Call Services for Snow Removal to Gallino & Sons, the lowest responsible bidder, as per the attached.

#### Discussion ensued.

- Mr. Nofi requested confirmation from Dr. Ring that on-call snow removal services would be utilized only if accumulated amounts of snow greater than seven inches fell, due to the inability of the district's on-hand equipment to clear large amounts of snow in a timely fashion. Dr. Ring provided his confirmation of the facts as presented.
- Mr. Nofi made mention of the familiarity of the Gallino name within the community and confirmed Gallino & Sons was awarded the bid as the lowest responsible bidder in accordance with the bid procedure in place by the district. Dr. Ring pointed out that the ownership of Gallino & Sons is related to Mrs. Evelyn Gallino, an employee in the building and grounds department. He explained this information was being shared solely for the purpose of full disclosure. Dr. Ring reported relatives of employees are not precluded from contracting with the district simply because they are related.

There was no further discussion.
