EXECUTIVE SESSION

At 5:04 p.m. Sean Callahan made a motion and Melissa Brown seconded to adjourn to Executive Session to meet and discuss confidential personnel matters pertaining to select employees.

All in favor – Motion carried 4-0

The Board exited executive session at 6:00 p.m. for the purpose of participating in a meeting of the Audit Committee.

At 7:09 p.m. the public session of the meeting commenced.

PLEDGE OF ALLEGIENCE

Mrs. Sullivan invited Dr. Ring to begin with the Superintendent's Report.

SUPERINTENDENT'S REPORT

Dr. Ring thanked the Board of Education and community for the opportunity to recognize and honor our outstanding students and staff.

Dr. Ring read a congratulatory speech for the Director of Health, Physical Education, Athletics and Intramurals, Mrs. Amy Agnesini, in recognition of her retirement and service to our students and community during her tenure at the Rocky Point Union Free School District.

Dr. Ring asked Mrs. Agnesini to remain at the podium to present the following awards:

Mrs. Amy Agnesini recognized middle school students Jason Staudte and Clare Levy, who were given the Suffolk Zone of New York State AHPERD award for their outstanding leadership in Physical Education.

MS. SUSANN CROSSAN, PRINCIPAL, ROCKY POINT HIGH SCHOOL

- Ms. Crossan recognized specific accomplishments achieved by several of our students. She invited 2nd Lieutenant Donald Conste and Mr. Wilfred Massidas, from Hofstra University to the podium to present special awards to two of our students who achieved very prestigious honors. Christofer Casswell will be joining the ROTC program at Providence College next fall where he plans to major in political science. Joseph will be joining the ROTC program at Norwich University and plans on studying construction management. They will participate in ROTC leadership classes and a physical training program while taking a full traditional course load. After four years of study, these two young men will graduate and become 2nd lieutenant officers in the United States Army and commit to serve through either active duty, the Reserves or in the National Guard. The application processes for an ROTC scholarship is difficult and includes a survey, interview, physical fitness test and examination by the ROTC Board. Earning this scholarship is difficult and very rare. Being awarded this honor is a true testament to Christofer's and Joseph's character, dedication and commitment.
- Ms. Crossan advised that students at the high school have been busy preparing for their end of year exams, events and activities. During the past month we had 84 students inducted into the Rocky Point Chapter of the National Honor Society. Over 200 community members were delighted to attend our annual Senior Citizen Prom sponsored by our Student Council and Be a Nicer Neighbor Club and our fine arts students participated in the pocket theater play, "The Curious Savage."
- Ms. Crossan recognized Matthew Brewer as the Salutatorian of the Class of 2016. Matthew is an exceptional student who is bright, articulate and ambitious. He flourishes in an intellectually demanding and competitive setting and has taken many advanced placement and honors courses throughout his years at Rocky Point. With a sharp mind, boundless energy and a love of learning, Matthew is ranked 2nd in a class of 268 with a GPA of 104.19. Matthew has been a positive contributor to the North Shore Youth Council working in a variety of leadership roles. He gives of himself unselfishly and genuinely enjoys assisting others. Matthew also uses his academic strengths to help classmates, as he is often specifically requested as a peer tutor. Matthew is a member of our National Honor Society, Math Honor Society, Math team, Mock Trial team, Science Club, and is the Vice President of the Senior Class.
- Ms. Crossan recognized James Gohn as the Valedictorian of the Class of 2016. James is by all measures an extremely bright young man of unusual character, morals and promise. He has devoted himself to being the best student he can be

and the result is brilliant. James is ranked 1st in a class of 268 with a GPA of 105.73. James has taken the most rigorous courses available to him and continues to maintain a most challenging course selection as a senior. His focus, drive and determination permeates everything he encounters. Mrs. Crossan was proud to share that James earned a perfect score of 800 on both SAT Subject exams in Chemistry and Physics. James is a member of our National Honor Society, Mathematics Honor Society, where he too assists other members of our student body as a peer tutor. He participated as a competitive member of our Soccer and Lacrosse teams and was selected as team captain for Varsity Soccer this past year.

- Ms. Crossan invited Mr. Andrew Levine, English Chairperson, to the podium to help in honoring Pooja Deshpande and Maggie Dowd for being nationally recognized by the National Council of Teachers of English. Each November, the NCTE invites high schools across the nation, to nominate two 11th grade student writers to enter two writing selections for consideration in the NCTE Achievement Awards in Writing. The NCTE Achievement Awards in Writing is a school-based writing program that was established in 1957 to encourage high school students in their writing and to publically recognize some of the best student writers in the nation. The number of eligible student nominees per school is set by NCTE and determined by current total enrollment in grades 9 - 12. This year, in November 2015, Mrs. Christine Blume, sponsored two juniors, Pooja Deshpande and Maggie Dowd, to represent RPHS in this honored and prestigious national writing contest. Over the next three months, Mrs. Blume worked very closely with Pooja and Maggie, helping them work through the writing process of drafting, editing, revising, and perfecting two writing samples for entry: one BEST piece that the student considers to be her best work regardless of the number of revisions, and one THEMED piece on a topic developed by the Achievement Awards Advisory Committee. In February 2016, Pooja and Maggie, submitted their writing, which you can find in full text on the school website. Mrs. Crossan thanked Mrs. Blume for her dedication and commitment to her students. She goes above and beyond to be sure they are acquiring necessary skills to be prepared for English requirements at the post-secondary level. This year, a total of 533 juniors across the country were nominated by their schools to participate in the 2016 program with 264 chosen as outstanding writers. All compositions were evaluated by national judges on content, purpose, audience, tone, word choice, organization, development, and style. Judges also looked for writing that demonstrated effective and imaginative use of language to inform and move an audience. The fact that these two young women were selected as winners is a testament to their exceptional writing ability. Ms. Crossan congratulated Pooja and Maggie for being nationally recognized for their hard work, talent, and success in their writing.
- Ms. Crossan asked Mrs. Nancy Hunter, our teacher of science research, to assist in recognizing five students who received special recognition for their work at the Long Island Science Congress in April. Kyle Markland's science project and presentation was recognized as one of the top exhibits as he was one of 20 students from Long Island selected to present his project at the New York State Science Congress at SUNY Buffalo this June. His research focuses on "A Cost

Effective Method for Improving GPS Positional Accuracy in Self-Driving Cars." This is the first time we have had a Rocky Point student selected to attend this state level in this competition. This honor is a true testament to Kyle's drive, dedication, and intelligence. Pooja Deshpande and Paul Leheste received Achievement Awards and recognition for their outstanding work. Ms. Crossan also congratulated Jade Pinkenburg and Bryant Liu as recipients of these Achievements Awards. However, they were unable to attend the Board of Education meeting. Pooja tested "The Biological Effects of Ionizing Radiation on Plant Seeds" and Paul's project was titled, "A New Memory Model: Classic Conditioning of Microglia". Paul and Kyle received Highest Honors for their projects by the Science Congress. Kyle was awarded 2nd place for the "Most Distinguished Categorical Project" in Earth, Space, and Energy and received \$300.00 in award money. Paul received the "Science Teachers Association of NY State – Suffolk Division Award" and received a \$50.00 award. Ms. Crossan announce that she is very proud of these students and their accomplishments.

- Ms. Crossan read a congratulatory speech for Mathematics Teacher, Mr. Peter Hoffmeister, and presented him with a plaque honoring his 34 years of service and his retirement.
